#### Old Business:

Miss Fleitz said the Courts are still closed because of the Covid-19, Mr. Hershman sent a notice to Mr. Migliori about paying the \$6,000.00. He hasn't heard anything from him.

**New Business:** 

Mr. Mark Sattler had a presentation to give to the Directors to consider enlarging the District from Cooley Canal, Wards Canal to Cedar Creek. This land belongs to property owners. Because of the high water and the dikes not in the Conservancy Work was done in 1972 + 1973 per Christine Fleits
District hadn't been touched in 74...

District hadn't been touched in 74 years. They were in disrepair. The Corp of Engineers walked the Dike last year and said there was a lot of erosion. There were trees and brush that needed cut and animals were tunneling into the bank. There was a dike failure near Corduroy Rd. this year.

Mr. Sattler said the Conservancy District could get a loan to fix the non-project area and then pay it back. There were also grands they could get. With a loan it could be paid back with the new assessments. Mr. Sattler said only the Conservancy District can do this and the County can help. He said that the Corp of Engineers has a program (develop and construction), where they will pay the first \$100,00.00 then if it went over it would be 50% nonfederal and 50% federal, also 40% nonfederal and 60% federal. Fema also has a program coming out soon called BRIC (building-resilience-infrastructure and community. Funding would be 25% cost share 75% funding.

These agencies can work with the District. Mr. Sattler said he wanted the Conservancy District to say they would look into doing this. He asked that the Conservancy District to do what was right for the community. Miss Fleitz said there would have to be a petition taken around to see if the property owners wanted it first.



Joyce Schmitz had a phone call and visit from a Lucas County Detective Mr. Kawleski, Mr. Boothby had called every government official on the Conservar

Kawleski. Mr. Boothby had called every government official on the Conservancy

District and The Judge wanted information on Mr. Boothby's complaints. Joyce explained and showed records that was in question. At this meeting she hadn't heard anything.

Also announced she was retiring as Secretary/Treasurer.
